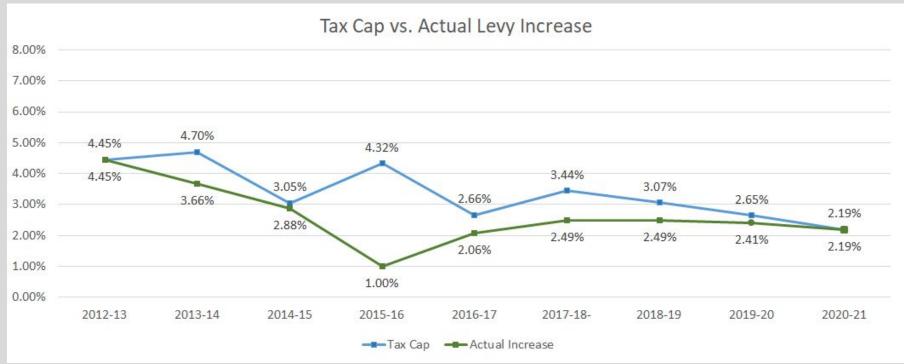

If revenues received are more than 1% lower than projections or actual spending is more than 1% more than projected, the NYS Director of Budget can reduce school aid.

Capital Outlay Projects

\$100,000 Project - Primary-Elementary School

 Work will include upgrading the window balancing at the Primary/Elementary School to allow for windows to open and close properly.

\$700,000 Project - Central Receiving and Storage Facility

 Work will include construction of a 9,000 SF central receiving storage facility on the site of the Canandaigua Operation Center. This work will include site modifications, structural, mechanical, electrical and plumbing work. This facility will assist in alleviating storage needs throughout the district.

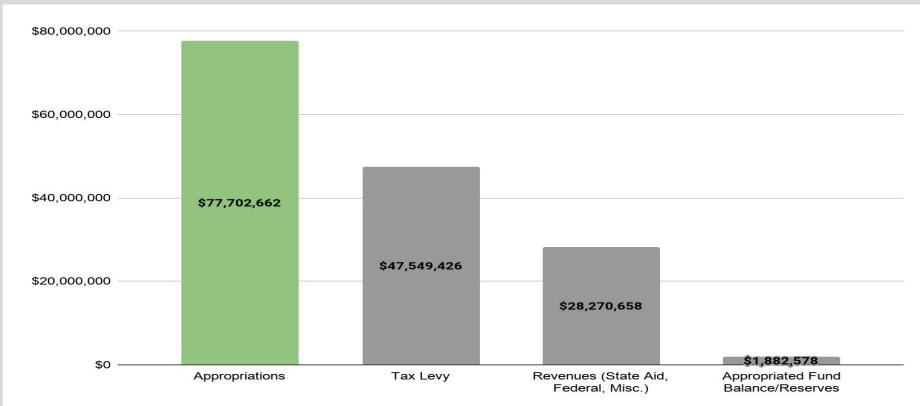

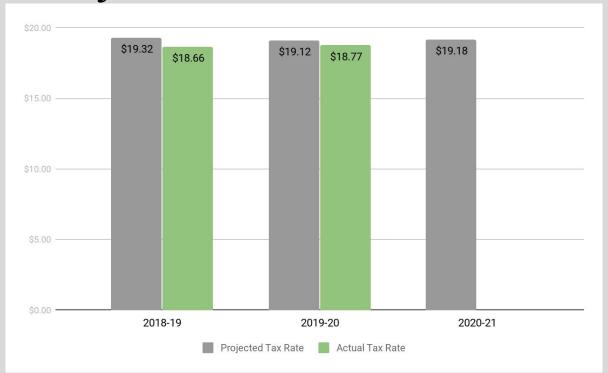

 - ☐ Low CPI will force lower tax cap calculation
 - ☐ TRS/ERS rates based on investment rate of returns
 - What will future health insurance increases be?
